In the event that a part is unavailable, we will attempt to obtain a replacement part or an equivalent substitute as quickly as possible. Parts replacement is solely at the discretion of Harmony Heating and Air Conditioning Inc. In the unusual event that we cannot provide a part replacement, Harmony Heating and Air Conditioning Inc. reserves the right to cancel your Home Protection Plan membership without notice or liability to Harmony Heating and Air Conditioning Inc.

If you move, coverage for the balance of the term will remain with Home Protection Plan member or is transferable to the new owner. A \$25.00 administration fee will apply. Please notify Harmony Heating and Air Conditioning Inc. of the new ownership of your Harmony Heating and Air Conditioning Inc. Home Protection Plan. Coverage may be transferred to your new home pending your equipment passes preinspection. A diagnostic fee may apply to failing equipment to pass pre-inspection.

Harmony Heating and Air Conditioning Inc's Home Protection Plan does not cover any damage caused by abuse, theft, vandalism, fire, flood, extremely cold temperatures, earthquake, other natural disaster, and acts of war or acts of God. Harmony Heating and Air Conditioning Inc. reserves the right to discontinue the Home Protection Plan at any time. In the event of cancellation of the plan, Harmony Heating and Air Conditioning Inc reserves the right to cancel without notice or liability. Enrollment in the Harmony Heating and Air Conditioning Inc. Home Protection Plan is subject to the company receiving payment as contracted. This agreement shall remain in effect for one year and shall be perpetual thereafter. Notice of cancellation must be provided to Harmony Heating and Air Conditioning Inc. in writing with 60 days notice subject to an early cancellation charge of remaining annual balance. With the Harmony Heating and Air Conditioning Inc Home Protection Plan you are eligible for one annual inspection every twelve consecutive months from your enrollment dated.

Furnaces: All of the following parts qualify for the 10% repair discount with the Harmony Heating and Air Conditioning Inc's Home Protection Plan for furnaces: gas burner and orifices, automatic gas control valves, gas regulator, electric ignition system, relay, flame sensor, pilot burner, thermocouple, generator, fan and limit controls, power burner motor, heating circuit transformer, venter motor assembly, roll out switch, vent system pressure switch, furnace low voltage circuit fuse, automatic vent damper / motor, aqua stat controls, flow switch, pulley and belt, fan motor, door switch, summer / winter switch, and low water switch.

Items which do not qualify, but not restricted to: ECM or DC Motors, Furnace casing, out of warranty heat exchanger,-furnace filters, seasonal lightup, gas or electric air conditioning controls, fire box / combustion chamber, diverter and venting systems, gas supply piping, manual shut off valves, duct work or heating distribution systems, boiler heating sections, water piping, components of boiler, water recirculating pump and motors, heat reclaimer, household fuses and standard and programmable thermostats.

Harmony Heating and Air Conditioning Inc. Home Protection Plan does not include the turn on or turn off of equipment, balancing of systems, descaling of water boilers, ducts or radiators, draining / filling un valved expansion tanks, or any other service considered plumbing, sheet metal or electrical work on housing wiring.

Air Conditioning: Plan valid on central air conditioners only. Window and Ptac air conditioning units are not eligible. Plan not valid on commercial air conditioning units or residential air conditioning units in commercial applications. Air conditioners acceptable for membership coverage must be free of leaks and in working condition prior to acceptance in the program. If not, the customer will be required to have the repairs performed and paid for before the customer can be acceptanced into the membership.

Accessories: Humidifiers, Electronic Air Cleaners, Media Air Cleaners, Condensate Pumps, Customer Owned Hot Water heaters are also eligable for coverage provided the accessory is in acceptable working order upon plan inception. Accessory pricing includes maintenance and replacement of humidifier pads and pleated filter media, and part replacement as necessary.

Specialty equipment: Individual pricing will be quoted for each piece of specialty equipment. Specialty equipment includes but is not limited to: Ductless Split Air Conditioning, Heat Pumps, Gas Boiler, Fireplace and HRV's.
